STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. House of Representatives has approved \$880 billion in cuts that will likely come from Medicaid.

One plan could cause **127,000 people in Utah to lose coverage from Utah Medicaid** (the state's Medicaid program). dxxix Utah would lose \$3.3 billion under another proposal. dxxx That money will be made up through firing public service workers, raising taxes or kicking people off of Utah Medicaid.



medicaid helps 72 MILLION

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Utah, 302,714 people are supported by Medicaid. dxxxi This includes 18% percent of moms giving birth, dxxxii 18% percent of children dxxxiii and 59% percent of grandparents and other seniors in nursing homes in Utah. dxxxiv Medicaid also supports veterans, students, working families and AFT members.



medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 91,000 students in Utah schools with disabilities. dxxxv



Medicaid accounts for 19 percent of all payments to hospitals nationwide. dxxxvi Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. dxxxviii



Utah receives \$3,548,000,000 in federal Medicaid funding annually. dxxxviii Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Utah public service jobs.

We're in this fight together. Bipartisan groups representing state legislators, state governments, county managers and cities are concerned about the fate of Medicaid. dxxxix And 71 percent of voters who supported President Trump oppose cuts to Medicaid.
