AFT + Offers Help for Those Impacted by Hurricane Harvey

If you are an AFT member who participates in certain Union Plus programs and have been affected by Hurricane Harvey in Texas, you may be eligible for financial assistance through the Union Plus Disaster Relief Grant program¹.

Union Plus Disaster Relief Grants of \$500 are available to eligible participants of one of the following programs:

- AFT + Credit Card Program²
- AFT + Senior Term Life Insurance
- AFT + Auto & Home Insurance or
- AFT + Mortgage Program

Participants who live in the following counties may be eligible for individual assistance: Aransas, Bee, Brazoria, Calhoun, Chambers, Fort Bend, Galveston, Goliad, Harris, Jackson, Kleberg, Liberty, Matagorda, Nueces, Refugio, San Patricio, Victoria and Wharton.

To qualify for a AFT + Disaster Relief Grant:

1. Your residence must be in a county qualifying for individual assistance money (to check if your county has been designated as an area eligible for individual assistance money, visit FEMA's disaster declarations page);
2. You must have experienced a significant loss of income or property within the past six months due to the disaster; and
3. You must have had a AFT + Credit Card for at least three months, AFT + Mortgage, AFT + Senior Term Life Insurance or AFT + Auto & Home Insurance for at least 12 months with that account or policy in good standing (be up-to-date on payments).

To apply for a disaster relief grant if you participate in any of the following programs, call:
